Watch the 2009 video carefully and follow along as you watch by reading and underscoring the various steps that are to be followed in the order given in Title 3, Chapter 1, Section 1. You will see that after the "state of the vote" was ascertained for the assembled states, Cheney did not call for any objections to the votes being certified prior to his ruling that Obama was elected. My reading of Title 3, Chapter 1, section 15 indicates to me that Cheney should have openly asked for any objections to the votes cast for the various candidates and the "state of the vote" after the list was tallied by the tellers. He did not. He simply ruled Obama was elected and moved on after the cheering DEMS quieted down to the VP election and then quickly declared the session over and dissolved the Joint Session. Anyone wanting to give an objection was never given the opportunity to take to the floor to do so OR ...
