Hi all. Time to Take Immediate Action:

For all practical purposes we have only until the end of this week to get a new legal tactic and action started to "sue Congress" for committing an unconstitutional act in confirming Obama and to ask the federal courts in that new lawsuit to stop/STAY the inauguration and swearing in ceremony until Obama's exact citizenship status is determined by the Courts or Congress holding fact finding hearings and an investigation. Monday is a national holiday and Tuesday is the 20th, the day O gets sworn in, unless we get a STAY of that. By this Friday afternoon, everyone in DC will be gone on a long weekend or starting to party down for the long weekend and run up to the inauguration. If we wait until the 20th or after to sue, then we are suing in regards to a "siting President" and it gets much harder. Also judicial "timeliness" is in play here. It is much better to sue now charging Congress violated the Constitution and try to STAY the inauguration and swearing in ... before the event and try to stop the event, than to wait until after the event has been consummated, i.e., he has been sworn in. And even if we don't succeed with this new type of lawsuit, we still can keep suing for a writ of "Quo Warranto" after he is sworn in and many other type actions. But suing now should not be discounted in the hopes that some suit later will take care of this. We need to sue in every venue now and later. We the people now have standing since we have been damaged and hurt by the actions of Congress on Thursday and we need to keep throwing the legal kitchen sink at everyone and anything that touches the process, including Congress, of confirming and swearing in an ineligible person as the President. Before Thursday Obama was simply a Presidential Candidate despite that sign he had hanging in front of him. After Congress confirmed him unconstitutionally on Thursday, he is now the President-Elect and now we the people can sue Congress for what it did as a federal body violating our Constitution. We the people now do have standing and we should file in Federal Courts as soon as possible to STAY the inauguration and swearing in charging Congress acted unconstitutionally.

If you are a member or have donated money to any conservative group, one of the below, or any other conservative action group, call or FAX them today to take action and have their legal team bring a suit in the federal courts asking for a STAY of the inauguration and swearing in of Obama due to Congress committing an unconstitutional act in confirming Obama since he was not eligible since he was not a "natural born citizen" of the USA since his father was never a U.S. citizen.

Please take action NOW! FAX or call now. Or at the least, send an email. Borrow the words from my Open Letter to the Conservative Groups above. Ask them to file suit in federal court to STAY the inauguration and swearing in of Obama until his exact citizenship status is determined.
